EZEEPAYMENTS.COM (EZEEPAYMENTS.COM) is committed to respecting your privacy and to complying with applicable data protection and privacy laws. This Privacy Policy is provided to help you understand how we may collect, use, protect, and otherwise deal with your personal information.

You acknowledge that by providing your personal information to EZEEPAYMENTS.COM , you consent to the processing of your data in accordance with this Privacy Policy. Types of Information Collected

The types of personal information that EZEEPAYMENTS.COM may collect include, but are not limited to:

Use of personal information by EZEEPAYMENTS.COM
